CONSIGNMENT TERMS AND RATES

This contract is a legal, binding agreement between the consignor (as noted on the face of this agreement) hereafter referred to as "seller" and REVIVAL CONSIGNMENT EXCHANGE, hereafter referred to as "RCX."

RCX reserves the right to determine acceptability and selling price of all merchandise.

COMMISSION: Seller will receive 70% of the final selling price.

SELLING PERIOD: Seller agrees to consign all items for forty (40) days.

- After forty (40) days, seller agrees the price will be reduced by 25%.
- After sixty (60) days, seller agrees the price will be reduced by 50%.
- Any item remaining unsold after ninety (90) day will be removed from the sales floor and donated to a local charity.

If the seller does not wish their merchandise to be sold at a discounted price, Seller agrees to make arrangements prior to the end of the consignment period with a representative of RCX for the removal of unsold consignments from the sales floor. Seller then agrees to pickup and remove from the property, all unsold consignments within (14) days of their removal from the sales floor. Any item remaining in storage for more than fourteen (14) days will be subject to a storage fee of \$10 per day, per item. When the cost of storage exceeds the price of the item, the item becomes the property of RCX and will be donated to a local charity.

OTHER FEES: All consigned merchandise is subject to a 3% credit card fee for those items purchased by the consumer with a credit card. There is no fee for merchandise purchased by cash or check. Seller agrees not to enter into a private sales transaction with any individual, company, or corporation prior to the expiration of the agreed selling period without the express consent of RCX.

PAYMENTS: Seller accounts are settled monthly. Checks for sales proceeds are mailed on the 5th of the following month.

LIABILITY AND INSURANCE: Reasonable precautions have been instituted to protect consignment merchandise, however, RCX carries no insurance for the benefit of the consignor, including but not limited to; damage, theft, fire, water damage or liability. Consignor agrees to hold harmless all owners, employees and agents of RCX and Emporium at Creekside Antiques from any loss, liability, damage or costs, including court costs and attorney fees, that they may incur due to my participation in consignments.
